MEMORANDUM OF UNDERSTANDING





Between

Bodoland University

&

Central Institute of Technology Kokrajhar

(Deemed to be University, MHRD, Govt. of India)

Bodoland University, Kokrajhar, BTR, Assam hereinafter referred to as "BU" and Central Institute of Technology Kokrajhar, BTR, Assam hereinafter referred to as "CITK", hereinafter individually referred to as "the Party" and jointly referred to as "The Parties";

ACKNOWLEDGING that

- 1. BU established in 2009, is a public state University, having its address at Kokrajhar-783370, BTR, Assam, India
- 2. CITK is a public Technical University established in 2006, and it is currently a Deemed-to-be-University under the Ministry of Education (MoE), Government of India, having its address at Kokrajhar-783370, BTR, Assam, India.

DESIRING to support the cooperation between the Parties in education and training programs

HAVE REACHED the following Memorandum of Understanding (MoU) effective as of 10th day of May, 2023:

ARTICLE I

GENERAL PURPOSE OF THE MOU

The general purpose of this MOU is to strengthen the bonds between the two institutions, and promote better understanding between the faculty, staff, and students of the respective institutions. It is expected that collaborative relationships thereby established will provide mutual benefits to both the Parties.

ARTICLE 2

SCOPE OF COOPERATION

The Parties agree to implement cooperation programs including but not limited to:

- (i) Joint educational, Cultural, Research, Technolgical activities
- (ii) Exchange of faculty members for lectures, research and discussions
- (iii) Participation in seminars and academic meetings
- (iv) Exchange of academic materials, Publications and other information
- (v) Other areas as mutually agreed upon by the Parties.

ARTICLE 3

LOCATION OF ACTIVITIES

- (i) The Parties agree to implement the programs stated in Article 2 at BU and CITK.
- (ii) Any changes of the location of the programs shall be mutually agreed upon by the Parties

ARTICLE 4

FINANCIAL ARRANGEMENT

- (i) This MoU will not give rise to any financial obligation by one Party or other.
- (ii) Each Party will bear its own cost and expenses in relation to this MoU, unless agreed by both the Parties.

ARTICLE 5

EXECUTING AGENCY

In order to implement this MOU:	
(i) BU appoints the Registrar, Bodoland University, her	einafter referred to as
BU representative.	
(ii) CITK appoints the, Registrar	hereinafter referred
to as CITK representative.	

ARTICLE 6

EFFECTIVE DATE, TERMINATION, RENEWAL AND AMENDMENT

- (i) This MoU shall take effect when signed and dated by the representatives of the two institutions and shall remain in force for a period of five (5) years or until such time as either institution terminates the agreement. Each party reserves the right to terminate this MoU for any reason by delivering a six-month notice in writing to the other.
- (ii). This MOU may be amended or revised at any time by mutual written consent of the Parties, and such amendment shall form an integral part of this MOU.
- (iii) Any amendments to the MOU shall be by mutual consent, executed by both the Parties. Such amendment or revision shall come into force on the date as may be determined by the Parties. Any activity already in progress will continue until completion as originally planned.

PART 7

SETTLEMENT OF DISPUTE

Any dispute concerning the interpretation and/or application of this MOU shall be resolved through negotiations or consultation between the Parties for the benefits of both the Parties.

ARTICLE 8

LIMITATION OF PERSONNEL ACTIVITIES

The Parties shall ensure that their personnel engaged in the activities under this MOU shall engage only in activities under the framework of this MOU.
