**Item No.37.01:Tabling of the report on the enquiry constituted on five employees.**

The Inquiry Report submitted by Inquiry Authority (IA) against five (05) charged officers of CIT, Kokrajhar for the inquiry conducted under Rule 14 of Central Civil Services (Classification, Control and Appeal) Rule, 1965 was opened by Registrar(i/c), CIT. The conclusion of the report in case of each charged officer was thereafter read by Director, CIT in front of the members sitting in the conference hall/attended online. The members decided to accept the report of IA for further course of action.
