

**MINUTES OF THE 6<sup>TH</sup> (SIXTH) ACADEMIC COMMITTEE MEETING  
HELD ON 25TH JANUARY, 2019 IN THE DIRECTOR'S CONFERENCE  
HALL, CIT, KOKRAJHAR**

The Chairman, Academic Committee, Central Institute of Technology Kokrajhar welcomes all the members of Academic Committee present in the meeting.

**Item No. 06.01: Confirmation of the Minutes of the 5th Meeting of the Academic Committee held on 22nd July, 2018 through circulation.**

The minutes of the 5<sup>th</sup> meeting of the Academic Committee were circulated to the members for seeking comments if any. As no comments were received from the members, the minutes of the 5<sup>th</sup> Meeting was placed for confirmation.

**Resolution:** After threadbare discussion, the members **confirmed** the minutes of the 5<sup>th</sup> (fifth) Academic Committee Meeting.

**Item No. 06.02: Action Taken Report (ATR) on the resolutions of the 5th Meeting of the Academic Committee held on 22nd July, 2018.**

An ATR had been prepared by the Institute on the resolutions of the 5th Meeting of the Academic Committee. Members are requested to discuss the ATR and suggest further course of action if any.

**Resolution:** The members discussed the **Action Taken Report** and **approved** it.

**Item No. 06.03: Granting "Deemed-to-be-University", status under "De-novo category", to Central Institute of Technology Kokrajhar.**

Central Institute of Technology Kokrajhar has been declared as an "Institution deemed to be University" by the Ministry of Human Resource Development of the Government of India vide Notification No. F.9-1/2016-U3 (A) dated December 13, 2018.

As per clauses mentioned in the referred notification, necessary steps have been initiated. Some of the major initiations are mentioned below.

1. The name of the institution would be revised as "Central Institute of Technology Kokrajhar (deemed to be University under MHRD, Govt. of India)".
2. As per the regulation of the AICTE, the existing Institute would apply for progressive closure, and for approval of its programmes under 'Deemed to be University' status, the Institute would have to apply afresh with new User Id. The process has been started.

3. The process of disaffiliation of the programmes of the existing Institute from the affiliating bodies (Directorate of Technical Education of Assam, Gauhati University and Assam Science and Technology University) has been initiated.
4. With due approval of the Chairman, Board of Governors of Central Institute of Technology Kokrajhar and the President, CIT Society, the Academic Committee of Central Institute of Technology Kokrajhar would be renamed as Senate. The constituents and functions of the Senate would be as per the provisions of the MoA of the Institute. The Members are requested to advice on this.

**Resolution:** The Committee ACKNOWLEDGED and APPLAUDED the Institute's efforts that have led to these significant achievements towards academic excellence. The following **resolutions** were approved.

1. The **name** of the Institute shall be *revised* as “**Central Institute of Technology Kokrajhar, Deemed to be University, MHRD, Govt. of India**”.
2. The Committee **approved** the process of **progressive closure**, and that of registering the Institute afresh that have already been initiated, as per the AICTE regulations.
3. The process of disaffiliation that has already started (**as per the MHRD Notification No. F.9-1/2016-U3 (A) dated December 13, 2018**) from the affiliating bodies was agreed by the Committee. Also, the Committee resolved that the Institute shall make an official intimation of the changes to the students and their parents.
4. The Committee approved that “**Academic Committee**” shall be renamed as “**Senate**” with due approval of the Chairman, Board of Governors (BoG) of Central Institute of Technology Kokrajhar. The constituents and functions of the Committee, however, shall remain as per the provisions of the MoA of the Institute.

**Item No. 06.04      Proposed academic programmes for the session 2019-20.**

The Institute needs to apply afresh for approval of AICTE of all its academic programmes under the deemed to be university status. All the existing programmes at the diploma and UG level would remain the same. In the deemed to be University proposal, CIT was mandated to start six new PG programmes in emerging areas so that locale-specific needs are addressed, natural resources of the region are harnessed and the region's economy is boosted up through newly designed curricula.

The proposed de-novo programmes are:

1. M. Tech in Food Engineering and Technology under the Department of Food Engineering Technology,



2. M. Des (Equivalent to M. Tech) in Multimedia Communication and Design under the Department of Multimedia Communication and Design,
3. M. Des (Equivalent to M. Tech) in Indigenous Artefacts and Design Heritage under the Department of Multimedia Communication and Design,
4. M. Tech in Green Energy Technology under the Department of Mechanical and Electrical Engineering (Proposed),
5. M. Tech in Water Resources and Hydraulic Engineering under the Department of Civil Engineering,
6. M. Tech in Agricultural Science and Technology under the Department of Food Engineering Technology.

As the course curriculum and syllabi for the first five programmes were finalized in the review meetings of CCDCs held on 20th July, 2018 at IIT, Guwahati, these may be started from the next academic session..

The programme at Sl. No. 6 above would be started at a subsequent phase in view of the fact that this programme would require considerable inputs from disciplines outside the range of subjects currently being offered by the existing Food Engineering Technology department of the Institute.

M.Tech programmes for four additional disciplines which were approved earlier by ASTU may also be started from the academic session 2019-20. Institute may formulate its own admission process for the above programmes.

The Institute has already conducted the admission tests, interviews and selection process for Ph.D scholars (as per the UGC norms) under the affiliation of ASTU, Guwahati. As the institute has now achieved autonomy in terms of deemed to be University status, modalities are to be framed for starting the PhD programme of its own from this session. The members were requested to comment on that.

**Resolution:** The Committee agreed that the Institute needs to apply for fresh approval for its Diploma, and Undergraduate (UG) Degree programs to the AICTE. In this regard, the following points of action were agreed upon unanimously by the Committee Members present.

- The existing Diploma programs shall continue to run unaltered.
- The Committee resolved the following changes in the Undergraduate Degree programs.
  - The Departments of Computer Science and Engineering (CSE) and Information Technology (IT) shall be merged together, and shall be named as Department of CSE. The faculties and other members in both the Departments shall belong to the newly formed CSE Department, and the student intake in the merged B. Tech CSE Program shall be 90 from 2019-20 Academic Session. The batches already enrolled in the IT Department shall continue through the same Department until they pass out.



- Departments of Electrical Engineering (EE) and Mechanical Engineering (ME) shall start B.Tech Programs in EE and ME, respectively, with the initial student intake of 45, followed by 15 vertical entry and 6 lateral entry in the 3<sup>rd</sup> Semester of the Degree Programs.
- Similar B.Tech programs in Basic Science and Humanities and Social Sciences (HSS) Departments may be considered by the Institute, once proposed with appropriate nomenclatures and scopes, and approved under the Deemed University.
- The Committee resolved (as per the feedbacks from the Committee Members from the respective Departments) that among the six proposed de-novo Post Graduate (PG) Programs, the following four shall commence from 2019-20 Academic Session with a student intake of 18 in each M.Tech and 15 in M.Des program.
  - M.Tech in Food Engineering and Technology under the Department of Food Engineering Technology
  - M. Des (Equivalent to M. Tech) in Multimedia Communication and Design under the Department of Multimedia Communication and Design
  - M. Tech in Green Energy Technology under the Department of Mechanical and Electrical Engineering,
  - M. Tech in Water Resources and Hydraulic Engineering under the Department of Civil Engineering
- The Committee also resolved that the remaining two de-novo Post Graduate (PG) Programs (as listed below) shall commence from 2020-21 Academic Session with student intake, as mentioned above.
  - M.Des (Equivalent to M.Tech) in Indigenous Artefacts and Design Heritage under the Department of Multimedia Communication and Design
  - M. Tech in Agricultural Science and Technology under the Department of Food Engineering Technology
- The Committee resolved that M. Tech program in CSE shall be proposed by the Institute for commencement from 2019-20 Academic Session.
- The Committee encouraged other Departments to develop novel M. Tech / PG program(s) for approval and commencement in future as a natural course of academic development of the Institute. Earlier, such proposals (e.g. M.Tech in Geotechnology, M.Tech. in Food Engineering and Technology, etc. under ASTU affiliation) were initiated, and the Committee encouraged all the Departments to develop such PG programs under de-novo category for future approval under the Deemed University.
- The Committee resolved that ordinances, rules and regulations for Diploma, UG, PG, and Ph.D Programs shall be formulated by appropriate Committees / Coordinators within the Institute, and approved by the Senate.
- From the coming 2019-20 Academic Session, CIT would admit students of its own registration under Deemed to be University, and other students enrolled in various affiliating body would be transferred (as migration). PhD admission was initiated, as it was planned to get affiliated by ASTU,

shall now continue as CIT registration, and the course work would start from 1<sup>st</sup> February 2019. Course work for PhD students shall be conducted by respective Departments. HSS will comprise of a large spectrum of sub-subject domains including Library Sciences for PhD.

**Item No. 06.05: Formation of Board of Studies in the academic departments of the Institute.**

The Institute proposes to review the course curricula and syllabi for its Diploma and Degree programs for minimizing the gap with current requirements. For this purpose, Board of Studies needs to be formed in all the academic departments including members from academia and industry as per the provisions of the MoA of the institute. The course curricula and syllabi for the PG and Ph.D programs may also be reviewed by these boards whenever necessary. Members are requested to comment on this.

**Resolution:** The Committee agreed that Departmental Boards of Studies (BoS) need to be formed, as per the provisions of the MoA of the Institute, in order to develop and/or modify and/or improve syllabi and course curricula for Diploma, UG, PG and Ph.D Programs for approval by the Senate from time to time.

Various levels of academic committees in the Departments (DPCs) as well as those at the Institutional level, including those related to examinations may be formed (please find the enclosed proposed Academic Organization Chart, as a separate attachment for your valuable inputs); while the admission and related activities may be carried out by a separate body.

**Item No. 06.06 Recruitment of teaching and non-teaching staff.**

Keeping in view the proposed academic programmes, teaching and non-teaching staffs would be required to be recruited as per the norms of the UGC. A proposal in this regard has already been submitted to the MHRD for approval. As per the revised proposed programmes, the Institute will prepare an updated proposal for recruitment of teaching and non-teaching staff for submitting to the MHRD. The members are requested to advice on this.

**Resolution:** The Committee opined that the matter needs to be discussed at the appropriate platform and the process of sending an updated proposal to the MHRD (as per the AICTE norms), which have already been initiated by the Institute, should continue.

**Item No. 06.07: Proposal for undertaking consultancy work.**

The institute express its willingness to formulate detail policies in order to give thrust to undertake consultancy/ expert study/ analysis/testing etc. from industry, external donors and agencies towards generation of IRG for the Institute and also for facilitating professional development and honing of competence. Members are requested to advice for forming procedures



for such activities and formulating the sharing of revenue between the Institute and the team of workers.

**Resolution:** The Committee resolved that the matter needs to be discussed in an appropriate Platform of the Institute. Detailed proposal(s) may be finalized in the Committee, and placed to the Finance Committee, and then to the BoG for approval.

**Item No. 06.08: Reporting on the Academic Activities of the Institute.**

Central Institute of Technology Kokrajhar is a centrally funded institute under Ministry of Human Resource Development, Government of India established on the 6<sup>th</sup> day of December, 2006. The Institute runs 3 years Diploma programmes in six (6) disciplines and 4 years U.G (B.Tech / B. Des) programmes in seven (7) disciplines of Engineering and design.

**Diploma Programmes are:**

1. Electronics & Telecommunications Engineering,
2. Computer Science and Engineering,
3. Control & Instrumentation Engineering,
4. Food Processing Technology,
5. Construction Technology and
6. Animation & Multimedia Technology.

**U.G. Programmes are:**

1. B.Tech. in Electronics & Communications Engineering,
2. B.Tech. in Computer Science and Engineering,
3. B.Tech. in Instrumentation Engineering,
4. B.Tech. in Food Engineering and Technology,
5. B.Tech. in Civil Engineering and
6. B.Tech. in Information Technology.
7. B.Des (Bachelor in Design)

**1. Reporting on the Activities undertaken by the Admission Committee.**

The Admission Committee takes responsibility for conducting the Entrance Examinations and Admission to Diploma, B. Tech (Direct Entry), B. Tech (Lateral Entry/Vertical Entry) and B. Des. programmes.

**Diploma Admission:** The total number of seats in Diploma programme is 180 with 30 in each of the six disciplines Out of the total number of seats, 80% of the seats are offered through the Entrance CITEE conducted by CIT, Kokrajhar while 20% of the seats drawn from those seats reserved for BTAD and Assam are offered through Polytechnic Admission Test (PAT) conducted by Directorate of Technical Education, Assam.



**B. Tech (Direct Entry) Admissions:** The total number of seats for B.Tech (Direct Entry) is 270 with 45 in each of the six branches. Out of the total seats under Direct Entry Scheme, 40% of the seats are offered for those candidates having qualifying marks in JEE Mains and 60% of the seats for those qualifying in the Entrance CITDEE conducted by CIT, Kokrajhar.

**Vertical/Lateral Entry Admissions:** Under the Lateral Entry Scheme, 15 seats in each branch are reserved for eligible candidates of CIT through Vertical mobility while 6 seats are open for qualified candidates of other AICTE recognized institutes through the entrance CITLET conducted by CIT, Kokrajhar.

**B. Des Admissions:** The total number of seats for B.Des.is 45 through Direct Entry and 15 through Vertical Entry. The admission for B. Des programme will be through UCEED and CITBDAT entrance examination.

**Reservation Policy:** The institute follows the following reservation policy.

- (i) 60% from BTC (60% ST, 5% SC, 15%OBC and 20% General)
- (ii) 20% from North-East region excluding BTC.
- (iii) 17% from All India excluding North-East Region.
- (iv) 03% for physically handicapped candidates irrespective of region.
- (v) In B. Des. Programme, all India norms are applicable for candidates admitted through UCEED. Candidates admitted through CITBDAT would follow the institute's reservation policies.

The selection of serial no.(ii), (iii) & (iv) follow the reservation policy for SC, ST, OBC and General as laid down by the Central Government. In the second round of counselling and admission, the vacant seats of BTAD region are offered to candidates of NE region. In the third round, the vacant seats are offered to all India candidates keeping the reservation for SC/ST intact.

## 2. Report on the Training and Placement activities of the institute:

### a) Facilitation for attending pooled campus placement drives/Job Fairs

The training & Placement Cell facilitated the 8<sup>th</sup> Semester Degree and 6<sup>th</sup> Semester Diploma students for attending pooled campus placement drive organized by different agencies in Guwahati and elsewhere.

- January 9, 2018:** Information as requested by the Corporate Recruitment Group of Powergrid for recruitment of final year Civil Engineering students at Powergrid communicated to students.
- February 22, 2018:** Students sent for attending walk-in drive for XL Dynamics India Pvt. Limited on 24th February, 2018 for passed out candidates at GIMT Guwahati.
- Aril 18-19, 2018. Pooled Campus Recruitment Drive** for recruitment of final year **Diploma and Degree students** in Civil Engineering/Construction Technology at **M/s Kalpataru Power Transmission Ltd. (KPTL), organized at** Girijananda Chowdhury Institute of Management & Technology **Guwahati** by **Nicco Ventures Limited. Three students of the B.Tech and three students of the diploma programme of CIT Kokrajhar got placed at KPTL at Vadodara** amongst a total of 22 students selected from NIT Silchar, Assam Engineering College, Jorhat Engineering College, Girijananda Choudhury Institute of Management and Technology, Tezpur University, NIT Meghalaya and CIT Kokrajhar. **For graduate engineers, the CTC per annum on confirmation would be Rs. 4.00 Lakh after one-year training during which CTC of Rs. 3 Lakh per annum would be paid. For diploma engineers, the corresponding amounts per annum would be Rs. 2.75 Lakh and Rs. 1.8 Lakh respectively.**



- iv) **May 7, 2018.** Sent students to the **MEGA Job FAIR – ICT Academy “LINK 2018” held at Royal Global University, Guwahati** organized by ICT Academy. Altogether **52 offer letters were issued to students of CI Kokrajhar** who attended the job fair for recruitment in seven different companies.
- v) **May 19-20, 2018:** Sent students to the “**Largest On – Campus Placement Drive**” for the Entire North-Eastern Region students held at **Assam down town University, Guwahati**. All of the 30 students who appeared received offer letter from one or other company that visited during the placement drive. However, the offered pay being less, the students are reluctant to join. Rather these students are opting for higher studies at NERIST, AEC and elsewhere.

**b) Facilitation of Summer Training for students in Undergraduate Programmes:**

During the academic session January-July 2018, the Training & Placement cell facilitated undertaking of summer training by the students of Undergraduate programmes of the Institute. Altogether 172 letters had been issued to various agencies, Institutes, industrial units, etc. for accepting the students of the CIT Kokrajhar for summer training. The Department-wise distribution of the training letters are as follows:

Whereas all students of the 6<sup>th</sup> Semester B.Tech and B.Des programmes have been accommodated for the mandatory summer training, about 10% students of the 4<sup>th</sup> Semester B.Tech programmes also attended training out of their own interest for their skill-development.

**3. Report on the initiatives on Industry-Institute-Interaction:**

A draft MOU on Industry-Institute Interaction between Bongaigaon Refinery of the Indian Oil Corporation Ltd. and Central Institute of Technology Kokrajhar was submitted to the Chief General Manager (i/c), HR of Bongaigaon Refinery on March 9 for consideration and approval. The approval of the draft and formal signing of the MOU are being awaited.

#### 4. Report on activities related to the Accreditation of National Board of Accreditation of the institute.

The institute had completed the institutional registration on NBA's e – portal by paying the required fee. As all the essential criteria of NBA prequalification were being satisfied by the targeted programmes (i.e. B. Tech in ECE, B. Tech in FET, B. Tech in IE, B. Tech in CSE, B. Tech in CE, B. Tech in IT), the NBA accreditation committee and the authority of the institute decided to apply for accreditation (NBA) for all the six programmes. As per that decision, the institute had initiated the process of application for all the six programmes as TIER II institute. Now under the new status of deemed to be University, the institute is in process for applying as **TIER I**.

**Resolution:** The detailed report was noted by the Committee and approved.

#### Item No. 06.09: Any other item with the permission of the Chair.

The Committee resolved on the following matters, as Members brought them up for discussion.

- HoD, Human and Social Sciences (HSS) Department has been given the responsibilities for developing a Detailed Project Report (DPR) for a “Center for Linguistics & Cultural Studies” to be placed in the Senate for approval.
- The Committee Members agreed that Alumni Association may be effectively used for teaching / training Diploma and UG students.
- The Committee unanimously resolved that after two two-year tenures of Mr. Bihung Brahma, Assistant Professor and HoD, HSS, as the Faculty Representative in the BoG, Dr. H. K. Kalita, Professor, CSE may serve for the next two years in the BoG in the same capacity.
- In view of the recent **Memorandum** from the **Ministry of Human Resource Development (MHRD), Govt. of India**, the Committee resolved that the Institute shall determine the calculations on 10% increase in student intake due to reservation for economically weaker sections (EWSs) for admission in the 2019-20 session according to the clarification / circular received from the MHRD.
