Section A: Confirmation of Minutes and ATR

Item No. 16.01: Confirmation of the Minutes of the 15th Meeting of the Senate of CIT Kokrajhar held on 4th January, 2024.

Item No. 16.03: Proposal for approval of the revised curriculum and syllabi for the 1st year courses of all the Under Graduate programmes of the institute.

The institute is in the process of revision of the curriculum and the syllabi of all the UG programmes of the institute in line with the National Educational Policy 2020 (NEP 2020). As partial completion of this process, the revised draft of the course structure and detailed syllabi of the 1st year courses of all the UG programmes was prepared by the concerned departments and placed before the meeting.

The members were requested to comment and approve the same.

Resolution: The curriculum and syllabi for the 1st semester courses of all the UG programmes were approved with the below mentioned modifications.

- 1. There shall be 1 credit for 1-hour of theory/tutorial class and 0.5 credit for 1-hour of laboratory/project/studio class.
- 2. In the detailed syllabus of the courses, minimal numbers of text books shall be included along with the reference books.
- 3. Tutorial classes for the courses shall be taken properly. Tutorial sheets shall be distributed to the students a prior and the solutions of the same to be discussed in the tutorial class.

- 4. The revision of curriculum for the Diploma and PG programmes (1st semester) shall also be completed before commencement of the 1st semester classes by following the same credit structure as mentioned in item 1 above.
- 5. Necessary amendments shall be made in the institute's regulations and ordinances, wherever applicable.

Item No. 16.04: Proposal for amendment in the clause no. 17.1 of the PhD Academic Regulation (RA 4) of the institute.

An amendment in the clause no. 17.1 of the existing academic PhD regulation of the institute was proposed as represented in the table shown below.

Members were requested to approve the same.

Resolution: The proposed amendments were approved.

Item No. 16.05: Proposal for approval of the syllabus of two-credit course to be adopted in the PhD course work of all the PhD programmes of the institute

in the PhD course work of all the PhD programmes of the institute from the current session onwards.

With reference to the resolution no. 15.06 of the Minutes of the 15th Senate meeting of the institute, the Humanities and Social Science department of the institute was asked to chalk out a plan for adopting the course. Accordingly, the referred department prepared the syllabus of the course in line with the recommendation of the University Grants Commission (UGC). The same was placed before the members. The institute proposed to adopt the course in the even (2nd) semester curriculum of the PhD course work from the current academic session (July 2024 onwards).

Members were requested to comment and approve the same.

Resolution: The members approved the syllabus and resolved the following:

- 1. List of recommended text books shall be included in the syllabus.
- 2. Course code and the semester for offering the course shall be decided by IPPC.
- 3. The course shall be taught by the department of Humanities and Social Sciences.

Item No. 16.06:

Proposal for approval of the revised Board of Studies (BoSs) of various academic departments.

As per the resolution no. 15.07 of the 15th Senate meeting of the institute, The BoSs of various departments of the institute were collected in a standard template as per the amended composition of the institute. A compiled draft of the same was placed in the meeting.

Members were requested to comment and approve the same.

Resolution: The members approved the Boards of Studies of the departments as proposed with a tenure of 2 years.

Item No. 16.07:

Proposal for approval for special admission into the PhD programmes of the institute in January, 2025 only for the GATE/NET qualified candidates.

As part of the efforts for increasing the Gross Enrollment ratio (GER), the institute proposed to take special admission of students into the PhD programmes of the institute in January, 2025 session depending on the availability of vacant seats. This admission shall be open only for the GATE/NET qualified candidates.

Members were requested to approve the same.

Resolution: The members approved the proposal for special admission into the PhD programmes of the institute from January, 2025 onwards. The same shall be applicable only for the GATE/NET/CEED qualified candidates.

Item No. 16.08:

Approval of the proposal for reforms in examination system of the institute.

As per the resolution no. 15.09 of the 15th Senate meeting of the institute, a draft proposal for implementing reforms in the examination systems of the institute was prepared by a two-member committee. The same was placed in the meeting.

Members were requested to comment and approve the same.

Resolution: The members approved the proposal. However, the following suggestions were provided.

- 1. A grade I to be provided to the students absent in the examination due to medical illness. Upon verification of the medical records the candidate will be given I grade. The concerned instructor will conduct a re-exam for the candidate(s) within 2 weeks and update the grade accordingly.
- 2. The existing grade "F" shall be renamed as "FP" (Fail due to poor performance).

Item No. 16.09: Approval of the draft modalities for admission of international students in various programmes of the institute.

With reference to the resolution nos. 11.13 and 15.12 of the 11th and 15th Senate meetings of the institute respectively, a draft of modalities was prepared for admission of international students in various programmes of the institute. The said draft of the modalities was placed in the meeting. Members were requested to comment and approve the same.

Resolution: The members approved the proposal.

Item No. 16.10:

Approval of draft of the ordinance on Students' event management proposed by the the office of the Dean (Student Affairs).

With a motive of encouraging and supporting students to actively participate in co-curricular and extra-curricular activities such as sports & games, technical events, cultural events and social activities (NSS) etc., the office of the Dean of Students' Affairs (DSA) prepared a draft of the ordinance for smooth management of all the students' activities in the institute. The same was placed in the meeting.

Members were requested to comment and approve the same.

Resolution: The members approved the proposal and suggested the following:

- 1. The document should be named as "Regulation on Students' event management".
- 2. The document should be revised by assigning clause numbers in place of bullet points.

Item No. 16.11:

Approval for creation of Faculty Coordinator posts for smooth conduct of students' activities.

For smooth conduction and management of all the students' related activities, the institute proposed to create the following posts of Faculty Coordinators for a tenure of three (3) years.

- 1. Faculty Coordinator, Sports and games
- 2. Faculty Coordinator, Cultural activities
- 3. Faculty Coordinator, Technical Events
- 4. Faculty Coordinator, Welfare/Youth activities

Members were requested to approve the same.

Resolution: The members approved the proposal and suggested that the coordinators shall prepare and circulate the approved year-long plan at the beginning of the year for all the activities of their respective domain.

Item No. 16.12:

Approval of draft of the ordinance on "Code and conduct of students" proposed by the the office of the Dean (Student Affairs).

In order to protect the rights of all the stakeholders of the institute and to maintain a conducive atmosphere in the institute appropriate for an institution of higher education, the office of the Dean of Student's Affairs (DSA) prepared a draft of an ordinance on code and conduct of students in the institute. The ordinance outlines students' conduct and disciplinary

policies pertaining to the students of the institute. The proposed draft of the ordinance was placed in the meeting.

Members were requested to comment and approve the same.

Resolution: The members approved the proposal and suggested that the document should be named as "Regulation on Code of conduct of students".

Item No. 16.13:

Approval of draft of the ordinance on "Hostel Rules" proposed by the the office of the Dean (Student Affairs).

In order to maintain discipline and a conducive environment inside and outside the hostel premises, the office of the Dean of Student's Affairs (DSA) prepared a draft of an ordinance on Hostel Rules for the institute and the same was placed in the meeting.

Members were requested to comment and approve the same.

Resolution: The members approved the proposal and suggested that the document should be named as "Hostel Regulation".

Item No. 16.14:

Approval of the draft proformas of the transcripts of Diploma, UG and PG programmes of the institute.

The institute's proformas for the transcripts to be issued to the graduating students of the institute were prepared for Diploma, UG and PG programmes. The said proformas were prepared in line with the proforma of Gauhati University and the Indian Institute of Technology Guwahati and the same were placed in the meeting.

Members were requested to approve the same.

Resolution: The members approved the proposal. It was resolved to use a common proforma of transcript for Direct, Lateral and Vertical entry students of all the UG programmes.

Item No. 16.15:

Proposal for allowing one PhD scholar of the institute who failed to register for the same from January, 2022 onwards.

A proposal from the Head of the department of Computer Science and Engineering (CSE) department was received requesting to allow one PhD scholar of the department, namely, Sri Mithun Karmakar, undergoing research under the supervision of Prof. Amitava Nag to renew his semester registration who failed to renew the same since January 2022.

As recommended in the proposal, the scholar had successfully completed all the academic requirements necessary for his PhD thesis submission, including the publication of three conference papers and three journal papers. The documents relevant to the proposal were placed in the meeting. He was requesting to allow him to pay all the pending registration fees and to continue rest of the processes of the programme for submission of the thesis. In view of that, the matter was referred to the Senate for consideration and approval.
