- The continuing/back students of CIT Kokrajhar are instructed to perform Renewal Course Registration on 20th January, 2020 from 9:00AM-5:00PM as per schedule of the Academic Calendar 2020. The Course Registration and Clearance forms are enclosed.
- 2. The payment of fees will be only through **SBI collect** and should be done **on or before 20th January, 2020**. However, mere payment of fees does not complete the process of course registration.
- 3. The concerned students must report with their original Identity Card to the respective **Course Registration Desk** and submit the duly filled course registration and clearance forms along with the Fee payment receipt. The Course Registration Desk for various programs will be notified on the day of registration.
- 4. The students who are unable to perform the Course Registration personally may request his/her representative for the same by submitting a photocopy of the student's Identity card.
- 5. The students failing to perform the Course Registration on 20th January, 2020 may request for the same on the following schedules with fine.
