- 20. <u>Price Variation Clause</u>: During the validity of the empanelment including the extended period, if the vendor sells any empanelled item to any other department / Organization at a price lower than the price fixed for CITK, the vendor must voluntarily pass on the price difference to CITK with immediate effect.
- 21. <u>Indemnity</u>: The selected vendor shall indemnify the CITK and user departments against all third party claims of infringement of patent, trademark/copyright or industrial design rights arising from the use of the supplied items and related services or any part thereof. CITK/ User department stand indemnified from any claims that the vendor's manpower may opt to have towards the discharge of their duties in the fulfillment of the purchase orders.
